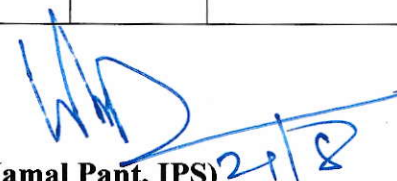

PROVISIONAL SELECT LIST

1. In pursuance to the Notification dated: 30.12.2021 cited at reference (1), recruitment process to fill up 71 posts of Armed Reserve Sub-Inspector of Police (CAR/DAR) (Men) including In-Service and Kalyana-Karnataka was initiated. The Endurance Test and Physical Standard Test to all the candidates who had applied for selection to the above said posts was conducted and further written examination was conducted on 08.01.2023 to all the candidates who had qualified in the Endurance Test and Physical Standard Test.
2. Whereas, as per the procedures laid down in the Cadre and Recruitment (Amendment) Rules, 2009, 2016 & 2020, after completing the above said process, provisional select list in the order of merit of candidates equal to the number of vacancies notified should be published. Accordingly, the provisional select list is prepared & published cited at reference(2).
3. In the said provisional select list the candidature of the candidates namely Sri.Ninganna B.Patil (Roll No: 5213366), Sri Mahanthesh S Hampannanavar (Roll No: 5213706), Sri Bharath Naik (Roll No: 5209123) and Sri Abhishek.V.K. (Roll No: 5205631) have given the affidavit letters regarding unwillingness to join the said post cited at reference(3) and 01 candidate namely Sri. Vivekananda B Karagi (Roll No: 5211532) is unfit in the medical examination as cited at reference (4). Therefore these 05 candidates candidature has been cancelled cited at reference(5).

4. Due to cancellation of said above candidates, 05 posts were remained unfilled. Hence to fill up these unfilled posts the provisional select list is prepared and published cited at reference(6).
- a) This list is subject to the outcome of the results in the medical examination to be held by a Medical Board constituted as per the rules.
- b) The fact that the name of the candidates figures in this list does not give them any legal right for appointment to the post which will be dependent on the aforesaid condition.
- c) This select list is subject to the final decision of the Hon'ble Karnataka State Administrative Tribunal / Hon'ble High Court of Karnataka / Hon'ble Supreme Court of India.
